The undersigned Developer hereby requests the City of Mesa's Chief Surveyor (480-644-3014, 480-644-3971 fax) to field verify that all lot corners and control points have been set as certified by the registered Land Surveyor named on the final subdivision plat identified below. Furthermore, the Developer has attached a "full-size" copy of said final subdivision plat for field verification purposes and acknowledges that a minimum of three working days notice is required prior to Mesa's Chief Surveyor performing the requested field verification.

The undersigned Developer understands that issuance of Right-of-Way Permits for the below named subdivision plat

shall be withheld until Mesa's Chief Surveyor confirms that all lot corners and/or control points are in place. Mesa's Chief Surveyor shall declare the inspection a failure should any lot corners and/or control points be found missing. The Developer accepts that before a re-inspection of said lot corners and control points can be made, a \$100/re-inspection fee must be remitted to the City of Mesa.
