Commercial Security Deposit

Commercial security deposits shall be set at two and one-half (2 1/2) times the highest monthly billing for the service address or like services as determined by Mesa for the service being provided by Mesa

All commercial utility customers will be required to place a cash deposit or a non-cash deposit in the form of a Surety Bond in an amount equal to the required security deposit.

Commercial utility cash and non-cash deposits on file with Mesa, upon request, will be reviewed after thirty-six (36) months of service and will be returned provided the customer has not been delinquent more than twice in each of the three (3) previous twelve (12) month periods, in the payment of bills or disconnected for non-payment during the previous twelve (12) consecutive months.

Payment Terms

Utility bills are rendered monthly and are due upon receipt. Accounts are considered past due if the payment is not received by the due date indicated on the monthly statement. The City reserves the right to disconnect any or all of a customers' services for non-payment of past due bills or for utility payment items returned unpaid by a financial institution. A new or increased deposit may be assessed to accounts with an unsatisfactory payment history.
