Subject: Mesa Fire and Medical Department Fees and Charges - Food Truck

Fire Inspection Fee (Citywide)

Purpose and Recommendation

The purpose of this report is to establish a new fee for fire inspections of Mobile Food Vendor vehicles and equipment by Fire Inspectors of Mesa Fire and Medical Department Fire Prevention Division. The Fees and Charges if approved by City Council will be effective as of October 5, 2021.

Background/Discussion

The Mobile Food Vendor ordinance recently passed by the City Council requires owners/operators of mobile food preparation vehicles to have an annual fire inspection and maintain a copy of the inspection with the vehicle. The proposed fee is an annual inspection fee of \$50 when the inspection is conducted by the Mesa Fire and Medical Department Fire Prevention Division. The amount of this fee is commensurate with the approxiamately \$150 inspection fee that brick and mortar restaurants incur once every three-years.

Alternatives

Council could decide not to implement the recommended fee. The recommendation is based upon Resolution 8894, 1/8/2007 providing for Fire Inspection fees and the updated fee amounts from Resolution 11154, 5/21/2018.

Fiscal Impact

The proposed fee is consistent with the Fire Prevention Division's cost recovery model. The City will accept proof of a fire inspection from another jurisdiction and therefore are not requiring vendors to utilize MFMD Fire Inspectors. The fiscal impact will be minimal and is projected at \$500.
