RESOLUTION NO. CFD EM1 RES 15

A RESOLUTION ADOPTING THE FINAL BUDGET BY THE BOARD OF DIRECTORS OF THE EASTMARK COMMUNITY FACILITIES DISTRICT NO. 1 (CITY OF MESA, ARIZONA) BEGINNING JULY 1, 2014 AND ENDING JUNE 30, 2015.

WHEREAS, in accordance with said sections of said title and following public notice, the Board of Directors met on June 26, 2014 at which meeting any taxpayer was privileged to appear and be heard in favor of or against any of the proposed expenditures or tax levies; and

WHEREAS, Maricopa County (the "County") is now the assessing and collecting authority for the District, the District Clerk is hereby directed to transmit a certified copy of this Resolution to the Assessor and Board of Supervisors of Maricopa County, Arizona.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE EASTMARK COMMUNITY FACILITIES DISTRICT NO. 1 (CITY OF MESA, ARIZONA) as follows:

<u>Section 1</u>. <u>Budget Adopted</u>. The District Budget in the amount of eight million, seven hundred four thousand, two hundred twenty-eight dollars (\$8,704,228) is hereby adopted as the Budget of the District for the fiscal year 2014-15.

<u>Section 2</u>. <u>Conflicting Resolutions Repealed</u>. All resolutions and parts of resolutions in conflict are hereby repealed.
