

## Real Estate Services ABANDONMENT APPLICATION

To apply for an abandonment, the following items must be submitted, please note that incomplete submittals will not be processed:

- 1. This completed application,
- 2. An exhibit, depiction, or map (e.g. recorded subdivision plat or County assessor's parcel map) and site plan showing new improvements (if applicable) highlighting the easements or right-of-way areas being requested for abandonment,
- 3. An exhibit, depiction, or map (e.g. recorded subdivision plat or County assessor's parcel map) and site plan showing new improvements (if applicable) highlighting the new easements or right-of-way needed for the project (if applicable),
- 4. Plat or document with Maricopa County recording number that granted the easement or right-of-way being requested for abandonment,
- 5. Written legal description and closure report with depiction of the easement or right-of-way areas to be abandoned,
- 6. Copy of Arizona811 (formerly Arizona Blue Stake) report identifying any current utilities in the easement or right-of-way areas requested for abandonment,
- 7. For Drainage easement extinguishments include a copy of the drainage report, and
- 8. The appropriate application fees.

Please check the appropriate abandonment request with the appropriate, **non-refundable application fee,** made payable to the City of Mesa:
